G. STAFF AND CONSULTANT REPORTS

G.1. 2025-231 City Administrator Report

Public Works staff continues mowing, spraying for weeds and mosquitoes, and recently completed blacktopping for the seal coat project; crack filling is scheduled for next week. Water/Wastewater performed potholing for lead service lines and replaced valves on TH75 in preparation for the 2026 reconstruction, while identifying and recording curb stops using GIS technology. Oil samples were taken from 32 VFI switches to monitor for moisture. Over the weekend, a planned 10-minute outage was conducted to isolate the 3-phase cabinet at the Sheriff's Office, after which staff set a new cabinet and replaced primary elbow connections; on Monday afternoon, a planned outage with the county enabled the community transit building to be transferred to the smaller generator. In addition, four wooden light poles at Redbird Field were removed and replaced with aluminum poles on new concrete bases, and eight inefficient 1500-watt mercury vapor lights were upgraded to energy-efficient 320-watt LED fixtures.

PROPOSED RESOLUTION

DECERTIFYING TAX INCREMENT FINANCING

REDEVELOPMENT DISTRICT NO. 22 OF THE CITY OF

LUVERNE

Proposed Resolution No. 13-25 to officially decertify Tax Increment Financing (TIF) Redevelopment District No. 22 Barck Housing Development, effective December 31, 2025. This decision follows confirmation that all financial obligations tied to the district have been satisfied, allowing the tax base to return to standard taxing jurisdictions starting in 2026. The Finance Director is authorized to complete all necessary steps for decertification, including notifying Rock County and the State Auditor, redistributing any excess increment funds, and closing out the district fund.

PROPOSED RESOLUTION
REGARDING A LIMITED USE PERMIT FOR TRUNK HIGHWAY
NO. 75 WITH THE STATE OF MINNESOTA, DEPARTMENT OF
TRANSPORTATION.

The Minnesota Department of Transportation requires a Limited Use Permit to the City of Luverne, allowing the installation and maintenance of beautification amenities-such as benches, planters, and waste receptacles-within the right-of-way of Trunk Highway 75. The permit is valid until May 28, 2035, and may be renewed for an additional 10 years with proper notice and documentation. All construction and maintenance must be approved by MnDOT and carried out at the City's expense, with strict adherence to safety, legal, and environmental regulations. The City must sign and return the permit along with a certified resolution to finalize the agreement. A motion was made by Council Member Kracht, seconded by

Christensen and Michael Hagen)

Property owners are requesting a waiver of subdivision requirements to split a parcel located at 1551 South Kniss into two parcels. Kings Custom Trailers is the current owner of the property, with Austin Christensen and Michael Hagan serving as co-owners of the company. They are proposing to subdivide and convey the parcel to accommodate current and future operational needs on the site. Requiring full compliance with subdivision procedures, such as public hearings and additional meetings, would impose unnecessary hardship and delay on the project without providing any corresponding public benefit.

Proposed Ordinance, Fourth Series
TO AMEND CITY CODE CHAPTER 153. ZONING, SECTIONS
153.008 AND 153.210 TO REGULATE CANNABIS AND HEMP
BUSINESSES

This proposed ordinance amends the city's zoning code to ensure local regulations align with newly established state business categories and definitions. The updated ordinance incorporates state-recognized terms like "cannabis retail business" and "lower-potency hemp edible wholesaler," clarifying operational permissions for these entities within specific zoning districts. The changes address expanded licensing and retail activities allowed under state law and ensure that local district permissions do not conflict with or add barriers beyond what state law prescribes. These amendments also enable the City to regulate new cannabis business types effectively while complying with state preemption rules. As this amendment is governed by ordinance, a roll call vote is required for approval.

A motion was made by Council Member Nath, seconded by Council Member Kracht, that this Ordinance be introduced and adopted. The motion carried by a unanimous vote.

J.6. 56 Proposed Ordinance, Fourth Series
TO AMEND CITY CODE CHAPTER 118. ZONING, CANNABIS
BUSINESS REGULATIONS

This proposed ordinance amends the cannabis registration ordinance to reflect changes in Minnesota state law by formalizing that applicants with "preliminary license approval" from the Office of Cannabis Management (OCM) must submit local retail registration applications before obtaining a full state license. Applications filed with only preliminary approval must include evidence of property interest and as much operational information as is available, with final documents to be submitted upon receipt of the valid state license. Requirements such as resident manager details and a certificate of insurance are now deferred until full state licensure and before retail sales are allowed, at which point the applicant must also pass a city-conducted preliminary inspection. These adjustments ensure city procedures align with state mandates, preventing unnecessary local barriers and expediting the transition from preliminary approval to full local registration. As this amendment is governed by ordinance, a roll call vote is required for

approval.

Cannabis Registration Application for Stozopoulos Holdings, Inc. DBA Coastless for a Retail Cannabis Microbusiness at 1202 South Kniss.

Dylan Stokes has secured preliminary approval from the Minnesota Office of Cannabis Management (OCM) for a cannabis microbusiness and has submitted all necessary documentation to the City of Luverne for local retail registration. The required \$500 registration fee has been paid, preliminary state approval has been verified, local zoning and buffer requirements are met, and property taxes at the retail location are current. In addition, resident manager information and evidence of control of the property have been provided as part of the application. Before Dylan Stokes is allowed to make any retail cannabis sales within the city, he must submit a copy of the final valid state license issued by the OCM, provide the required certificate of insurance, and permit the City to conduct a preliminary site compliance inspection. State law requires local governments, to accommodate applicants who have received preliminary state approval, ensuring they do not impose procedural barriers beyond what is permitted by state or local ordinance.

222 East Main Street is zoned within the downtown district allowing mixed-uses through conditional use permits. The planning commission held a public hearing on July 8, 2025. In summary, the planning commission recommended the following findings and orders: a parking garage on Main Street will benefit residents and businesses while minimally impacting the surrounding area, the garage's location will not hinder future projects and has practical considerations like easy access to electricity and proper drainage addressed.
